⁵ Allotments (058-14/15)

A letter from the Sandy & District Allotment & Leisure Gardener's Association was considered together with an email from Central Bedfordshire Council explaining the delay in processing the soil testing of the site in Sandy. The email was noted and the site suitability was awaited.

It was **RESOLVED** that the residents on the Council's waiting list Cllr Aldis should be asked if they still wanted an allotment plot.

12 Smartwater - Belam Way (059-14/15)

An email from Mr Milstead was considered. He attended the meeting and gave a presentation on the possibility of introducing Smartwater in Sandy. He explained that the project could be in conjunction with the police or Central Bedfordshire Council and could involve local groups. He may have to apply for funding if the police and CBC were not involved.

It was **RESOLVED** that if funding was required he should apply to the Council by November this year for it to be considered in the 2016 budget.

⁶ Engayne Avenue Estate (060-14/15)

⁷ CCTV (061-14/15)

He reported that CBC want WiFi to connect the cameras to the control centre at Dunstable and Council is to decide if they go with the Wifi or stay with the control centre at Stevenage. Costings are awaited. They are also deploying a mobile camera and asking if Council want to be part of it. It was suggested that this would be beneficial in Belam Way and Cllr Aldis would put this request forward.
