
### 6 Items for Information (13-2018/19)

The Licensing Team were not aware of any planning issues at the above club. However the consumption of alcohol is not a licensable activity and therefore the addition of a beer garden would not be licensable. That being said, it would be useful to have an updated plan for the club. I will write to the club to request this.

With regards to potential noise nuisance, incidents of nuisance should be reported to our Pollution Team who will be able to investigate. Any interested party also has the right to call for a review of a premises licence/club premises certificate at any time if they wish to do so.
