03.10.19	CB/19/03126/ FULL Priory House Monks Walk Chicksands SG17 5TQ	Conservation Area: proposal to erect a temporary security fence along the section of the Sandye Place Academy playing field belonging to St Swithun's Lower School for three years at Dovecote to South-East of Sandye Place, Park Road, Sandy.  <b>Resolved:</b> to make no objection to this application as per the plan, not the description as this is misleading. Sandy Town Council would not wish to see the fence extended to the Dovecote.

## 6 Items for Information (49-2019/20)

Members noted the following updates on enforcement cases:

- a) CB/EN/19/0248 – The Willows – case has been closed as the breach of planning control has been remedied.
- b) CB/EN/19/0366 – 30 Pym's Way – investigation is ongoing.
- c) CB/EN/18/0427 – 4 High Road, Beeston – investigation is ongoing.

Members noted that application CB/19/01921/FULL for 1 Brickhill Road, Sandy which STC objected to, has been granted by Central Bedfordshire Council.

Members noted the appeal for Land North of Sunderland Road has been adjourned until 11 February 2020 and will take place at Jordan's Mill.

Members noted that the Council had received two near neighbours letters regarding Shannon Court – one for five self-contained flats and one for eight self-contained flats. The Administrator contacted CBC to query why the one for eight self-contained flats was being applied for again, as this had already been granted. She was told that the near neighbours letters were sent in error as these types of application

(PADO -Prior Approval) do not get consulted on. With regard to the query about the application for eight self-contained flats the Administrator was told that the applicants have applied again to extend the time in which they can complete the works. Members were concerned about fire safety surrounding this development and asked that a letter be sent enquiring as to if the Fire Service had been consulted on this application.
