Background

4. The Council have raised several concerns around the safety of the A1, including roundabouts, crossings, and pollution. The Council have written to the Hon. Richard Fuller MP and are awaiting further updates from his office. The removal of roundabouts and safety matters around the A1 were raised in the House of Commons on 29th April 2021. Details on the statement made are included in this report for Members' information on the to provide context to SG19's question.

Information

5. Mr Stephen Allen of the SG19 Group has asked the following question of the Council;

Is the Council aware of Sir Edward Leigh's statement in the Commons regarding the A1? If so, how does STC intend supporting him/his idea?

6. In a statement in the House of Commons the Hon. Sir Edward Leigh MP stated;

The A1—the Great North Road—is a beautiful road linking Scotland and England, and I think that to honour the upcoming jubilee we should rename it The Queen's Highway. Why not? But it is not an entirely safe road. I have spent hundreds of hours on it, and there are many fatalities on it. I cannot understand why all the roundabouts have been stripped away between Newark and the Black Cat roundabout, but going south from the Black Cat to the north circular there are still roundabouts. There are also many crossing points in Lincolnshire and other places. Will the Minister now commit to really upgrading the A1 to make it entirely safe by getting rid of all the traffic lights, roundabouts and crossing points? Let us make it a true Queen's Highway.

7. In response the Hon. Rachel Maclean MP, Parliamentary Undersecretary for the Department for Transport stated;

I fully agree with my right hon. friend's suggestion for renaming that beautiful road, and I am sure that the Transport Secretary, who is listening carefully, will take that away and consider it. I am happy to say that we are investing significant sums in making the A1 safer and more reliable as a result of our near-£1 billion A428 improvement scheme, and there will be a major reconstruction of the Black Cat junction on

The Al should be Queen's Highway, says MP

A CONSERVATIVE MP is campaigning to rename the Al the "Queen's Highway" to mark the monarch's platinum jubilee.

Sir Edward Leigh, who was knighted by the Queen in the 2013 Birthday honours, told the Commons the "beautiful" Great North Road should be renamed to celebrate Queen Elizabeth's 75 years on the throne next year. Sir Edward said: "The A1, the Great North Road, is a beautiful road linking Scotland and England and I think to honour the forthcoming jubilee we should rename it the Queen's Highway. Why not?"

Rachel Maclean, a junior transport minister, said Grant Shapps, the Transport Secretary, would consider it.

The Al replaced the London to Edinburgh Great North Road, used by mailing coaches. The 18th-century highwayman Dick Turpin is said to have ridden from London to York along the road in under 15 hours.

Yesterday Sir Edward said the modern

Al should be upgraded to make it safe. "Get rid of all the traffic lights, the roundabouts, the crossing points, and let's make it a true Queen's Highway," he said.

Local highways bosses have previously called for the A1 to be given motorway status to help it cope with the high volumes of traffic. Sir Edward's constituency of Gainsborough, Lincs, is not far from the 410-mile long thoroughfare.

Purpose of the Report

This is the fourth Neighbourhood Steering Group report for STC. The purpose is to provide Members
with an update on progress that is being made and the key actions at each Council meeting as agreed
in the Terms of Reference. Since the last full meeting of Council, the Steering Group has held further
meetings and a series of working group meetings to progress actions agreed.

Recommendation

2. That the Council note the information within the report.

Background/Information

- 3. The Steering Group's project plan has been reviewed by the CBC NP Officer. We've received good feedback and a request to share this as a good example with other NP Steering Groups.
- 4. The Steering Group's focus for the past 6 weeks has been to prepare for the initial community engagement at the Spring Craft Market on 31 May. We will be at the community stand throughout the day and will have display boards that explain what a Neighbourhood Plan is, and why it is important for Sandy residents to engage and let their views on planning be known. We will also have a simple questionnaire for people to complete that will also be available online as part of our evidence gathering.
- 5. We hope to see you all on the day, however we will also circulate the questionnaire to all Councillors to ensure we get input.
- 6. Ahead of the day we will launch our Facebook page that will have a short video as a way to introduce the topic as well as eye catching and thought provoking posters, how to contact us and get involved. Our Logo will be on all collateral with a recognised brand that people can easily identify.



- We envisage that this will be the first of a series of engagements with the community over the next few
 months to help us shape the Vision and Aims of the Neighbourhood Plan based on the evidence
 gathered.
- 8. We have made our first grant application for bespoke High Street Regeneration and Social Infrastructure Grant. This is a new funding stream that we felt we should try and take advantage of even though we are quite early in the development of the plan. This is only for Plans that include High Street regeneration plans, so we used the output of the People and Places survey and feedback from the community focus meeting to develop an outline of a scheme. If we are successful, the next step will be an evaluation of the project to ascertain if it would be likely to be successful. If this phase is passed, then we could get a grant of £15k for technical support to develop a more formal proposal.

Purpose of the Report

Background

- 5. The EWR consultation was included on the last Full Council agenda on 12th April 2021. Members asked that the Consultation be included for discussion again on a Full Council agenda to allow Members more time to consider the consultation and allow more meeting time to discuss the Council's input/response.
- 6. A Member raised a query about development corporations, which are mentioned within the consultation technical documents. The Clerk raised a query about the purpose of development corporations with EWR and the MP's office.

Information

- 7. The Clerk received the following information on development corporations;
 - 1. Response from Rt Hon. R Fuller, MP's office;

The government in the Chancellor's March 2020 Budget and in the same month through a DHCLG policy paper (<u>'Planning for the Future'</u>), signalled its intention to develop the case for up to four new development corporations in the Ox-Cam Arc in or around Bedford, St Neots / Sandy, Cambourne and Cambridge.

It came from the work of the NIC's Partnering for Prosperity: A new deal for the Cambridge Milton Keynes-Oxford Arc study in 2017 after the government had asked the National Infrastructure Commission to look at how infrastructure development in the Cambridge-Milton Keynes-Oxford Arc could maximise the potential of the area.

In February this year, the government published the Planning for sustainable growth in the Ox-Cam Arc: an introduction to the spatial framework. In 1.23 of the document, it states "We have also made a commitment to examine the case for development corporations, linked to the new transport hubs around East West Rail stations."

If you read on in the document it provides indicative timelines with a consultation expected this summer. I suggest this is the paper to look at but that there will be more to come in future months.

2. Response from EWR Corporation Team

The government is examining the case for up to four new Development Corporations in the Ox-Cam Arc in or around Bedford, St Neots/Sandy, Cambourne and Cambridge.

More information can be found within the Ministry of Housing, Communities and Local Government's planning White Paper here and their Spatial Framework here.

Dear Chair and Clerk,

The East West Rail Company, which was established by the government to deliver the East West Rail link between Oxford and Cambridge, has launched its non-statutory public consultation on their proposals for the new railway between Bletchley and Cambridge, via Bedford.

You can view the consultation here https://eastwestrail.co.uk/consultation

We welcome this significant investment in transport infrastructure, particularly if it supports the delivery of a wider network of sustainable transport links that will benefit our existing and expanding communities. This investment will also be important for the development of our existing local economy and make us an attractive area for new businesses which will also benefit our residents. We are concerned about the impact some of the options being considered would have on the communities on the Marston Vale line. Whilst we understand there is a balance to be struck between connecting thriving communities for the future and making some compromises, we want the best for our communities. This is a once in a generation investment in infrastructure and there is a real opportunity to explore truly ambitious solutions to maximise the benefits to our residents and businesses and minimise the impact as far as possible.

The East West Rail Company's consultation is open until 9 June 2021 so we will consider the proposals fully and listen to the community before responding to the consultation. We would encourage you to share the proposals with your communities as far and as wide as possible. The East West Rail Company will continue to carry out briefings with ward and parish councillors, as well as residents and community groups, along the proposed route.

Recommendation

2. To note the updates and approve the Group's ideas for the Welcome Back Fund.

Background

3. The Sandy Town Centre Group is an external group to the Council, comprised of volunteers. Cllr. J Hewitt sits on the group as a representative of Sandy Town Council. The aim of the group is to consider the town centre and issues related to it and look at ways to improve and enhance the centre of Sandy.

Information

4. The group continues to meet monthly, with regular attendance from a core group of volunteers. At a meeting of the group on 11th May 2021 the group considered the 'Welcome Back Fund' and how this funding could be used to benefit the High Street. The group considered the funding application criteria and spend categories, and after discussion it was agreed to put forward the following recommendations to STC;

4.1 Make the High Street /Market Square more attractive for visitors

- Additional mobile flower planters to be installed outside Shannon Court. (Wood Green has volunteered to help keep these watered and maintained).
- Potential replacement of existing planters in the town centre with newer planters. This would need to be done later in the year, after the summer planting season. Further review established that this would be too costly for the current grant fund one planters were purchased and the highway 'made good' under the existing planters.
- Light up the trees in the Market Square with pea lights these would remain in place to enhance our Christmas lights too. Additional three trees in total.
- Add bunting to make the High Street more festive this summer.
- Promote the use of the Community Stand.

4.2 Promote the High Street and local businesses within it

Lamp post flags to be installed - "Shop Sandy" & promotion events and features of Sandy such
as Green Wheel /RSPB. Overall themes and designs to be decided, with possibility of
businesses using the banners for advertising if a contribution is made.

 Shop Sandy – Promotion Week/month, print a leaflet to be delivered to every household encouraging people to use the town centre and include vouchers/offers from retailers in the town to be used for a defined period. Businesses on the call felt that this would have the most impact on footfall – several have already committed to participate, including All Seasons, The Flower Room, JS Alsford. Cllr Gibson will be contacting others in the High Street this week to gauge interest in participating. We will have a mockup of a leaflet to share with the businesses.

• Get our High Street Map and Directory professionally printed and displayed in the Town. Alternatively have a new centre map and directory designed, potentially as a wider community engagement activity. Other towns, such as Buntingford use town centre maps and directories effectively to advertise what it in the town. The Clerk has contacted an artist who is running a community project to create a map of a nearby town to see if a similar project could be run in Sandy. The project would use community engagement to produce a map that used residents' drawings to develop a map highlighting key features in Sandy.

4.3 Events

If events can take place when businesses are open during normal trading, then these will
increase footfall. At present we can only safely have small events at the Community Stand or on
a large event on a Sunday/Bank Holiday. To have impact it was agreed events need to be on a
regular schedule or people forget to come. We will see what impact we get from the 31st May
event and then may look to add others later in the year dependent on resources.

Next Steps

5. The Town Clerk is to cost the proposals and make a report for the STC Full council meeting on 24th May. The grant funding will need to be applied for by 27th May.

Other Items

- 6. The only other news is that for the time being, Eat Feast will not be resuming their monthly visit to Sandy which is a real shame as this did bring people into town on the Friday evening when they were operating. This is due to the difficulties in meeting COVID19 guidelines and queuing systems in the space available to them.
- 7. Our next meeting will be on 8th June at 5.30 on Zoom again.
